## Working with SCAP to Prevent Eviction

or many years, Gary Morant enjoyed a successful career as a chef, even partnering with celebrities on occasion. But in the spring of 2018, he was diagnosed with stage 4 cancer and was no longer able to work. He applied for SSD and was approved, but he couldn't expect his first check until the end of a 6-month waiting period. And because he had some private disability insurance, he didn't qualify for much SSI. This tough financial situation caused Mr. Morant to fall behind on his rent and soon he faced eviction proceedings.

Fortunately, Mr. Morant was put in touch with David Crossman, a Legal Aid Society of Northeastern New York (LASNNY) attorney, and with the Schenectady Community Action Program (SCAP). Crossman says, "I went to court with Mr. Morant for two separate non-payment cases. The first time, in August 2018, we put together a payment plan for him and Donna Gonzalez from SCAP was able to provide \$275 towards this plan."

But Mr. Morant's financial issues weren't over yet. A few weeks later, Gary fell behind again. His payment was due on a Friday, but he didn't have the full amount until the following day, Saturday. He called the landlord to let them know he'd be a day late, but by Monday morning, the landlord had already filed for another warrant of eviction. (continued pg. 6)

has been great so far. During the first half of the year, we finished our 2018 statistics. Last year we handled 13,731 cases for all clients, providing life changing legal services to meet our clients' essential needs. We reached 360,908 people through other legal assistance avenues including community legal education, outreach presentations, distribution of brochures, and visits to Legal Lifelines on our website. We continue to provide high levels of full representation in courts and before administrative agencies, as well as advice and brief service that allows many clients to make better legal decisions.

We continue to evaluate and improve our full program of legal services. We continue to work with many community partners and are active in Domestic Violence Task Forces and Coalitions in nine counties. 76 pro bono lawyers accepted referrals from us in the first half of the year. One of them, the team of Paul Kietzman and Dave Glasel at Barclay Damon, handled our first case for a group: Nonprofit Incorporation for the ALERT Partnership. Our pro bono volunteers are available to help other low income community groups seeking incorporation or legal advice.

Our lawyers became even more seasoned, winning the cases described in this newsletter and many more. We continue our commitment to high quality

individual representation even as we explore ways to have greater systemic impact in our communities. Tara Glynn a staff attorney in the Plattsburgh office, helped a group of mobile home tenants create a mobile home co-op. 74% of the families went from tenants to homeowners through her work.

In addition, our Advocacy Coordinator, Victoria Esposito, filed suit against the Roman Catholic Diocese of Albany, St. Clare's Corporation, St. Clare's Retirement Income Plan, and various individuals tasked with managing these entities on behalf of two eligible clients who were promised pensions from St. Clare's Hospital. Working with a team of lawyers from the AARP Legal Foundation, with Professor David Pratt of the Albany Law School, and with Gary Stone of Brooklyn Legal Services, Victoria is a key part of the legal team.

During this year we also recruited a number of exciting new Board members. This newsletter highlights one of our North Country Board members, Lloyd Grandy II of the Carlisle firm. Also joining us this year are Thomas Adams of Conboy, McKay, Bachman & Kendall, LLP, and Kate Mastaitis of Donnellan and Knussman, PLLC. Our volunteer Board of Directors provides guidance and oversight to all of the work that we do; they are invaluable.

We were blessed with a baby boom and have recently welcomed back several attorneys who were on parental leave. It is very gratifying to see the next generation of Legal Aid babies and parents continuing the fight for equal access to justice.

We welcomed a new Development Associate, Jenifer Whiston, and we formally recognized Deanne Grimaldi as our Director of Development and Communications. If you think our Communications are better, sharper, and edgier this year, you can thank them.

### Dedicated to Pro Bono Work

arc Ehrlich received the American Bar Association's (ABA) Pro Bono Publico Award, presented by the Standing Committee on Pro Bono and Public Service. The Committee works to ensure access to justice through the expansion and enhancement of the delivery of legal and other law-related services to the underserved through volunteer efforts of legal professionals nationwide.

A dedicated pro bono attorney for over three decades, Marc is a perfect fit for this accolade. The Legal Aid Society of Northern New York (LASNNY) nominated Marc for the award for his dedication to the Private Attorney Involvement (PAI) program. Marc says, "I started taking pro bono cases from legal aid in the mid 1980s and I took my first referral from LASNNY simply because they called me and asked." He continues, "It goes to show that if you pick up the phone and ask someone to volunteer, sometimes they'll say yes."

Marc estimates that in the past three decades, he's taken on about 500 pro bono cases, spending multiple hours on each case. Marc says, "I do everything from preparing the petition to going to court to answering follow-up questions." And when it comes to accepting pro bono clients, Marc wants them to be as local as possible. He explains, "I want the clients to be within easy driving distance or on bus routes." Marc continues, "If you're doing pro bono work, you really need to look at the geographic location of your client, you don't want them to be spending an inordinate amount of time trying to get to your office."

One of Marc's previous clients says, "Had he not been able to take the case, I don't know what I would have done." Ramona is the mom to 3 children, including a son on the autism spectrum, and a few years ago she was going through a divorce. She says, "I had a lot of debt and filed for Chapter 7 bankruptcy. But because of the kids, it was important to keep my home and my car." Thankfully, Marc was able to help her do exactly that. Ramona says Marc made the legal process easy to understand. She says, "If I had questions, I was always able to speak directly with

Marc, rather than having information relayed through a middle person." Ramona's bankruptcy was discharged in June 2014 and she is still her home to this day. Thanks to Marc's dedication to pro bono work, Marc has helped hundreds of clients just like Ramona.

Marc owns a private practice in Troy, New York and is Board Certified in Consumer Bankruptcy Law. In addition, he has served as a Chapter 7 panel Trustee for the Northern District of New York since 1991. Marc is a three-time winner of the Distinguished Service Award for Private Attorney Involvement

for pro bono work by the Legal Aid Society of Northeastern New York, and was awarded the President's Pro Bono Service Attorney Award by the New York State Bar Association in 2001 and its Small Firm Pro Bono Award in 2013. He was awarded the Barry A. Gold Law Firm Leadership Award by The Legal Project of the Capital District Women's Bar Association in 2004.

LASNNY is thrilled that Marc was selected for this honor and was glad to be there when he received the award at the ABA's Annual Meeting on August 10, 2019 in San Francisco, California. Lillian Moy, LASNNY's Executive Director says, "Marc's commitment to assuring fairness to those who cannot afford representation is outstanding. LASNNY and his clients are fortunate to have him as a volunteer."

## Client Story: (cont. from front)

Crossman explains, "Instead of picking up the payment a day late, the landlord filed for a warrant of eviction on Monday based on Mr. Morant's 'default' under the stipulation. I filed an order to show cause arguing that the landlord was supposed to notify me that they were seeking a warrant and citing a case that says payment a day late and a dollar (actually \$1.56) short should not result in forfeiting a tenancy. In Gary's case, he wasn't even a dollar short, just a day late. At the court appearance, Judge Frost ordered the landlord to accept the payment." Crossman was happy with the successful outcome but acknowledges the gravity of the situation. He recalls, "As Gary signed a retainer for me to represent him in court, he looked into my eyes and said, 'My life is in your hands.'"

As for Mr. Morant, the 61-year-old is still battling cancer. He is thankful for the company of his three children and life partner. "She's been by my side throughout everything." And he can't say enough good things about LASNNY and SCAP. "I don't know where I'd be without them," he says. "David helped me out numerous times with landlord negotiations as well as giving referrals for other types of assistance." While Mr. Morant navigates his very serious health issues, he can at least rest easy when it comes to his housing.

## PAI Program Update

t was a very busy summer with the Legal Aid Society of Northeastern York New **Private Attorney** Involvement department. We have been celebrating the many accomplishments of our pro bono

attorneys and interns throughout the summer and implementing the much needed expansion of our housing programs.

In April, we celebrated Sharon Couch Debonis and Amanda Rose at NYSBA's President's Service Awards. Sharon and Amanda were NYSBA's Third and Fourth Judicial recipients. Sharon Debonis, a Troy solo practitioner, was nominated as the Third Judicial recipient for her active involvement in our Attorney for the Day program, both as a mentor and volunteer. Sharon has participated in all three locations – Albany, Troy and Glens Falls for our Attorney for the Day program. Amanda Rose, also a solo practitioner, was nominated as the Fourth Judicial recipient for her active participation in our Fulton, Montgomery and Schoharie county pro se divorce clinics.

In May, we celebrated Marc Ehrlich on the American Bar Association Pro Bono Publico nomination at the Rensselaer County Bar Association Annual Dinner. Marc Ehrlich of Ehrlich & Acordia PC is a longstanding and active contributor of our Bankruptcy Referral program, assisting low-income debtors by providing them Chapter 7 discharges. Ehrlich assists some clients who are at risk of immediate garnishment and subject to enforcement of liens. He will be formally recognized at the American Bar Association Annual Meeting in August, held in San Francisco, CA.

In June, we celebrated Jellisa Joseph at the Capital District Women's Bar Association's Annual Dinner on her New Outstanding Attorney nomination! Joseph, Associate Counsel with the NYS Senate Democratic Conference, has been an active volunteer with our Closing the Gap program since 2018. Closing the Gap is a pro se program that assists unrepresented litigants with attorneys, remotely, for limited, brief services in their consumer debt and housing matters. Joseph has eagerly utilized the Private Attorney Involvement office space available for pro bono attorneys at the new Center for Civil Legal Services at 95 Central Ave in Albany.

#### Attorney for the Day Expansion:

More recently the surge of new tenant protection laws passed in June.

It has been an exciting and overwhelming time applying the new laws that have been implemented for stronger tenant protections.

Attorney for the Day (AFTD) is a collaborative effort with participating courts, pro bono attorneys, Legal Aid

# Society of Northeastern New York and Albany Law School student volunteers to assist tenants facing eviction in the cities of Albany, Troy, and Glens Falls. Private firms such as Whiteman, Osterman and Hanna, LLP have been sending associates on a monthly for several years. Whiteman associates gain valuable negotiation and litigation experience participating in this program.

Attorney for the Day's goal is to sustain or assist low-income tenants with transitioning to new affordable housing, to address concerns with inhabitable properties, and/or to provide tenants with the information and advice that they need to advocate for their housing rights. It has been very exciting to hit the ground running putting the new tenant protections into practice.

#### **Increase in Name Change Referrals:**

There is a rise of persons who identify themselves using other nontraditional gender terms, research suggests. Legal Aid Society of Northeastern New York, In Our Own Voices, Inc. and private firms like Nixon Peabody, LLP respond to the needs of gender nonconforming persons, meaning that they don't always self-identify as the sex they were assigned at birth, who wish to change their name and gender.

LASNNY offers these services through our Private Attorney Involvement - Name and Gender Marker Change referral project. Persons contact us directly or are referred by community organization, such as, In Our Own Voices, Inc. to connect with probono leaders such as Tina Sciocchetti and Dan Hurteau, partners at Nixon Peabody, LLP (see pictured). Petitions are filed in the Supreme Court of the applicant's jurisdiction to change their name.

Some may not understand how important it is to be addressed and identified in a manner that is consistent with their own self-identification. Our pro bono attorneys at Nixon Peabody, LLP get it. Discrimination and fear of rejection in employment, healthcare and educational institutions add an additional barrier for the LGBTQ community to overcome.

## Board Profile: Lloyd G. Grandy II

The Legal Aid Society of Northern New York (LASNNY) recently welcomed a new board member to its roster. Lloyd G. Grandy II, the recent addition, spent the first few months of his life in Massachusetts, but after his father retired from the U.S. Air Force, the family returned to their ancestral home in St. Lawrence County. The family has strong ties to the area, dating back as far as seven generations. Lloyd spent his childhood and early adulthood near the family farm, eventually earning his B.A. and M.Ed. from St. Lawrence University.

Lloyd says that he had always been interested in law, but didn't make the decision to begin law school until his early 30's. He attended an accelerated program at Thomas M. Cooley Law School where he received his Juris Doctor cum laude. Upon graduation, he practiced law in Lansing, Michigan, but eventually Lloyd returned home to St. Lawrence County.

In January 2014, Lloyd joined his current firm, The Carlisle Law Firm, P.C., where he is a shareholder. Lloyd focuses mainly on social security disability cases, but he says he is involved in a little bit of everything that his firm does – from personal injury to workers' compensation cases.

Lloyd joined the LASNNY board in early 2019, but he's no stranger to the organization's work. He says, "LASNNY has been a great resource for my entire career and I've been touting the benefits for years." Lloyd entered into his new role on the LASNNY board with plenty of leadership experience. He is past President of the St. Lawrence County Bar Association and recently joined the National Aluminum Production Heritage Association as a member of their Board of Directors.

When he's not working or giving back to the community, Lloyd says he relishes the chance to spend time with his family. He and his wife, Dorothy, have three children and they enjoy getting outside as much as possible. Lloyd says, "We live in such a beautiful part of the state – the St. Lawrence River is in our backyard, Lake Placid is not far away, and Montreal and

Ottawa are within easy driving distance."

Lloyd says that living in a rural area like St. Lawrence County means he sees people struggling to make ends meet everyday. He says that the need for legal aid has always been apparent and abundant and he hopes to be seen as "the local boy who came back and is happy to be home serving his neighbors." As he wraps up his first year in the position, Lloyd says, "Being on the board for LASNNY is an amazing opportunity and I'm looking forward to giving advice and being available first hand."
