### The global pandemic of COVID-19 is harming our community.

LASNNY has changed the way we work so that we can serve vulnerable people without endangering their health or the health of our dedicated advocates. Legal services are essential in times like these, and so we are mounting an incredible effort to adapt our services and prepare for what's ahead.

**The communities we serve will be the hardest hit by this pandemic**—they are the first to feel the impact of job losses and health crises. They have no resources to fall back on during this dangerous time, and their access to food, shelter and health care was precarious long before the virus arrived. Some measures are emerging to try and protect this population, such as a moratorium on evictions, but without legal advocacy, these efforts will not protect those people who need them most.
