Our LITC serves the following counties: Albany, Clinton, Columbia, Essex, Franklin, Fulton, Greene, Hamilton, Montgomery, Rensselaer, Saratoga, Schenectady, Schoharie, St. Lawrence, Warren and Washington Counties, and the St. Regis Mohawk Tribe. The clinic does not generally provide tax return preparation. Although the clinic receives funding from the IRS, the clinic, its employees, and its volunteers are not affiliated with or endorsed by the IRS or its employees. A taxpayer's decision to obtain representation from an LITC will not result in the IRS giving preferential treatment in handling the dispute or problem and will not affect the taxpayer's rights before the IRS.
